/School Mission: Our mission is to provide a range of functional academic, independent living, social and behavioral services emphasizing the development of the whole person. Through our individualized focus on the acquisition of language, independence, social, academic and behavioral skills, each individual is provided with the support and tools to participate in society to his or her full potential.

School Description: Creative Learning Center (CLC) is a non-public school in Redwood City. CLC uses multiple research and evidence based programs including TEACCH, Relationship Building instruction, PBIS, and SCERTS. CLC's mission is to educate the whole child, as a result, the teaching methods are individually developed based on each student's learning style, strengths, and weaknesses. Additionally, CLC provides specialized academic instruction, speech and language services, occupational therapy, behavior supports, social skills training, and student and parent counseling. CLC educates and services students on the Autism Spectrum and other neurodevelopmental disorders in grades K-12+ [ages 5-22].

The CLC program incorporates multiple recreation and fitness activities which are organized by the CLC staff. Activities include but are not limited to activities such as bike riding, roller blading, and yoga and other mindfulness activities. Extracurricular activities including Spanish, gardening and computer activities are also available to students as appropriate. Appropriateness of activities is determined by the student's ability and IEP goals and objectives. Field trips are planned in accordance with the student's needs, ability and interest. They attend field trips with other students and staff to places like the restaurants, museums, movies, stores, parks, Moffat, bowling, miniature golf, and nature walks. Furthermore, art activities are a part of every classroom's program and schedule.

CLC provides community-based instruction to address pre-vocational, vocational, and transition skills. Students may walk or be transported in the CLC vehicles to regularly implement the students' Individualized Intervention Plan and to address goals in the community. Activities may include opportunities for practicing safety awareness, making purchases at stores, doing laundry, eating at restaurants, working on farms or department stores, and other related vocational activities. Many times, our service providers including the SLP, OT, and/ or BCBA may go on the outings with the groups to address students' individual goals in a functional setting.

Additionally, students at CLC get the opportunity to interact with typically developing peers throughout the volunteer program. Every year students from local Jr High and High Schools student volunteer in our schools to play games, assist, and mentor the children and young adults attend CLC. CLC also offers sibling groups, game nights, reading nights, and math challenges for the students' families, volunteers, and community members/ organizations.

B. Pupil Outcomes

Where the most viable option, LEAs were required to administer the statewide summative assessments for ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:
 - Aligned with CA CCSS for ELA and mathematics;
 - Available to students in grades 3 through 8, and grade 11; and
 - Uniformly administered across a grade, grade span, school, or district to all eligible students.

The 1:1 instructional assistants are trained to be ABA therapist and classroom instructional assistants. They rotate from student to student as needed and, as appropriate, to ensure generalization. Students receive SLP and OT individually or in small groups depending on the students IEP requirements. These services can take place in the classroom or in the designated OT/SLP areas. Addendum
